Rights Respecting?

- Scotland would benefit from thinking about children in conflict with the law from the perspective of rights
- Making upholding rights the basis of what we look to 'do' through the youth justice system



Priority issues

- Poverty discrimination
- Understanding and participation
- Children in adult courts
- Hidden, restrictive practices
- Ignoring the child victim
- Criminal records
- Intensive community based supports
- Children who commit the most serious offences
- 16/17 year olds



Recommendations

- Define children as under 18
- Social inclusion and social justice as prevention
- Strengthen the participation of children in conflict with the law
- Uphold the rights of victims
- Strengthen early intervention and diversion
- A shared responsibility approach-community/family support
- Support the specific needs of children in conflict with the law
- Appropriate approach to children's criminal records
- Ensure due process for all children
- Improve our approach to the deprivation of children's liberty
- Respect the rights of children who commit the most serious harms and wrongs



Impact of COVID-19

- Delays to court process and Children's Hearings
- Changes in offending/offence types
- Responses to non-compliance with restrictions, including wider criminalisation
- Relationship difficulties and conflict in the home
- Basic needs and access to services
- Children who are deprived of their liberty
- Police contact
