Who are we?

Established in 1996, Together (Scottish Alliance for Children's Rights) is an alliance of non-governmental organisations (NGOs) and interested professionals working to improve the awareness, understanding and implementation of the UN Convention on the Rights of the Child (UNCRC) and other international human rights standards across Scotland.

We do this by:

- promoting the UN Convention on the Rights of the Child;
- helping individuals, local authorities, companies, schools and children's organisations to integrate the UNCRC into their work;
- monitoring and reporting on progress made at a Scottish and UK level.

Membership has grown from 30 to nearly 500 organisations and individuals. Together has established a reputation as a leading source of expertise on children and young people's human rights at a Scottish and international level.

Vision and Mission

Everything we do is guided by our vision and mission.

Vision: All children and young people growing up in Scotland have their human rights respected, protected and fulfilled.

Mission: We work to inspire and enable everyone in Scotland to put children and young people's human rights at the heart of everything they do.

What does Together do?

Promote the UNCRC

Together raises awareness of children's rights and the UNCRC by working closely with our members, local authorities and parliamentarians. We also share accessible and informative resources with the public via our website and social media channels.

Together has been relentlessly pushing for children's rights to be protected in law, which has led to the passing of a Bill which, once in force, will "fully and directly" incorporate the UNCRC into Scots law. This will mean that the Scottish Government and public bodies have to put children's rights at the heart of everything they do, and children will be able to challenge them in court if their rights are breached.

Throughout the incorporation process, Together provided leadership by supporting, informing and coordinating civil society and ensuring children and young people's voices were heard.

Together will continue to play an important role in advancing children's rights in Scotland as the UNCRC Bill is implemented.

Direct engagement with children and young people

At Together, we work to ensure that children and young people's voices are listened to, respected and that they influence the world around them. Over the last two years, we supported children and young people to directly influence the UNCRC Bill and shape plans for a new human rights law for Scotland.

In 2020, we facilitated <u>two engagement sessions</u> with children and young people to help shape the UNCRC Bill.

In 2021, Together developed child-friendly briefings and held three events with children and young people to share their views with the <u>National Taskforce for Human Rights Leadership</u>. Each event focused on a specific topic: The right to a healthy environment; The rights of disabled children and young people; The rights of black and brown children and young people.

Help everyone in Scotland to integrate the UNCRC into their work

Together provides training and practical guidance to members, local authorities and Scottish Government on how to enact a child-rights-based approach to their work.

Together uses the UNCRC and recommendations from the UN Committee on the Rights of the Child as well as the expertise and experiences of our members to advocate for the implementation of policies and legislation in Scotland and the UK which respect, protect and fulfil children's rights.

Together submits <u>consultations responses</u> to the Scottish and UK Governments highlighting what more needs to be done to fulfil children's rights. Together also produces <u>briefings</u> focused on children's human rights. These can be aimed at MSPs, organisations or individuals.

Monitor and report on progress in Scotland and the UK

National: Each year, with the help of our members, Together produces a <u>State of Children's Rights Report</u> to monitor compliance with children's human rights in Scotland. This report highlights progress and gaps and makes recommendations to address shortcomings. This report is shared with the Scottish and UK governments.

State of Children's Rights Report (SOCRR) 2021

Our 2021 State of Children's Rights Report will highlight promising rights-based practice from across Scotland and tips to help organisations and individuals put children's rights at the heart of everything they do. We have been working with members to shape the report throughout the summer and hope to publish it in early 2022.

International: The UN Committee on the Rights of the Child ('UN Committee') checks what countries are doing to implement children's rights. Every country that has <u>ratified</u> the UNCRC has to report on how it is fulfilling its obligations under the Convention.


As an alliance of NGOs in Scotland, Together also gives evidence to the UN Committee on children's rights and the implementation of the UNCRC.

This means that the UN Committee is not only listening to the UK and Scottish governments, but also to the experiences of grassroots organisations and the children that they work with. Drawing on the expertise of our members, Together produces an alternative report to the UK Government's report highlighting specific issue areas where children's rights are not being upheld. Recommendations in Together's report are used to hold the Scottish and UK governments to account to their human rights obligations under the UNCRC.

State of Children's Rights Webinars 2021:

Together's anti-racism work



Over recent years, the Black Lives Matter movement has generated much-needed conversations about racism and racial inequalities around the world. However, anti-racist activism has existed in Scotland for decades.

Whilst the organisation has historically supported anti-discriminatory work, we have not previously sought to embed anti-racism throughout all areas of our work.

Being actively anti-racist is critical to our roles as both an employer and as an organisation working towards a Scotland where all children and young people in Scotland have their human rights respected, protected and fulfilled. We know that we have a lot of work to do.

Anti-racism and our membership


When members join Together we ask them to agree to the statement below:

At Together, we are pro-actively taking steps to become an anti-racist organisation and want our culture as a membership organisation to reflect this.

We expect members to challenge racism in all forms, wherever they see it, to commit to listening and learning about racism and make changes to become antiracist that are meaningful and sustained.

We don't have all the answers! We are very much still learning and we've already received some helpful feedback to incorporate into this work. We would love to hear from you about the anti-racism work that your organisation is doing.

What is the UN Convention on the Rights of the Child (UNCRC)?



The UNCRC is the most complete statement of children's rights ever produced and is the most widely-ratified international human rights treaty in the world.

The UNCRC has 54 articles that cover all aspects of a child's life and set out the civil, political, economic, social and cultural rights that all children everywhere are entitled to. It also explains how adults and governments must work together to make sure all children can access their rights.

The UNCRC is followed by a number of agreements that add further rights for children – these are called "Optional Protocols":

- 1. The Optional Protocol on the involvement of children in armed conflict
- 2. The Optional Protocol to the Convention on the sale of children, child prostitution and child pornography
- 3. The Optional Protocol on a communications procedure

General Comments

The UN Committee produces General Comments which give extra explanation about the rights in the UNCRC. These can look at a specific right or a certain theme. They set out what governments should do.

These include:

- Implementing child rights in early childhood (No. 7)
- The right of the child to the enjoyment of the highest attainable standard of health (No. 15).
- Children's rights in the child justice system (No. 24)

Days of General Discussion

The UN Committee holds a day of General Discussion every two years. The purpose of General Discussion Days is to gain a deeper understanding of the contents and implications of different articles or topics in the UNCRC. Recent days of discussion have covered:

- Children's Rights and the Environment (2016)
- <u>Digital media and children's rights</u> (2014)



Other Human Rights Treaties and instruments

The UNCRC is not the only international treaty which contains

essential rights protections for children. There are other human rights treaties, laws and instruments which provide rights protections for children at an international, European and UK level, such as:

- International Convention on the Elimination of Racial Discrimination
- International Covenant on Economic, Social and Cultural Rights
- International Covenant on Civil and Political Rights
- Convention on the Rights of Persons with Disabilities
- Convention on the Elimination of Discrimination Against Women
- <u>Universal Periodic Review</u>
- Human Rights Act
- Council of Europe instruments



The UNCRC in Scotland



The UK ratified the UNCRC in 1991. Since then, Scotland began to put certain articles of the UNCRC into its laws - but not all of them.

Children and young people, supported by Together and our members, led a long campaign to see their rights fully protected in law.

On 1st September 2020, the UNCRC (Incorporation) (Scotland) Bill was introduced to the Scottish Parliament. First Minister, Nicola Sturgeon, said it would incorporate the UNCRC into Scots law "fully and directly", to the maximum extent of the Scottish Parliament's powers.

On 16th March 2021, MSPs voted unanimously to pass the Bill - a historic step that inspired children's human rights defenders across the world. Once implemented, the Bill will make children's rights under the UNCRC part of the law in Scotland. The First Minister said she wanted to deliver a "revolution in children's rights" through a Bill that went as far as possible in protecting children's rights, whilst staying within the powers of the Scottish Parliament.

The new law will start six months after it gets Royal Assent from the Queen. Although the Bill has been challenged in the Supreme Court, the Scottish Government is continuing to prepare for commencement.

Together and our membership must continue working hard to ensure that the new law has the impact in children and young people's lives that we all want to see, and that there is a culture change through which children rights are recognised and realised across all areas of their lives.

Working groups

Advisory groups

Together sits on a number of governmental and non-government advisory groups to ensure that children's rights, as outlined in the UNCRC, are considered in decision-making.

Elections and the Board of Trustees

As a Together member, you have the opportunity to stand for election as a trustee. Together's Board is made up of trustees elected by Together's membership and drawn from its member organisations and individual members. The Together Board comprises 10 Trustees, elected to the Board on a rolling basis.

Together's Board of Trustees has overall decision-making authority and is involved in governance and recruitment. Trustees are elected at Together's AGM, which takes place in Autumn, and sit for a three-year term. Trustees may participate in subgroups to advance the goals of the organisation.

As a trustee, all members of the Board are expected to act in the interests of Together. Trustees do not represent the interests of any organisations to which they are connected through employment, personal relationship or any other role but are trustees in an individual capacity.

The Board meets four times a year unless there is a need for an Extraordinary Board meeting(s) due to specific circumstances. The role of trustees usually requires a time commitment of up to one day per month for all trustees and up to two days a month for trustees who are office bearers. There may be occasions when additional time commitment is required.

Standing for election

Trustee vacancies are advertised via social media, e-newsletter and directly to Together members. Together encourages applicants to have an informal discussion with the Director or other trustees in advance of applying.

Applicants are requested to submit Biographies and Expression of Interests prior to the AGM, at which the election takes place.
All trustees are expected to have an expressed commitment to

children's human rights in line with Together's vision and strategic plan.

Terms of membership

Responsibilities of Together members

All Together members must sign up to the responsibilities of being a Together member. These are:

- Sign up and commit to Together's vision, mission, values, antiracism work and to base their work according to the principles enshrined in the UNCRC and broader human rights treaties.
- Take measures to raise awareness of children and young people's human rights among colleagues, supporters and partner organisations and bodies.
- Make efforts to put children and young people's human rights at the heart of everything they do and share knowledge and experience to help partners and other organisations to do the same.
- Share developments in the sector, expertise in the form of reports or resources, information about upcoming events etc. with Together to advertise in our fortnightly e-newsletter.
- Contribute to the financial sustainability and independence of Together by paying an annual membership fee.
- Promote Together's work and amplify Together's messages, resources, blogs, consultation responses etc.
- Not knowingly or negligently act in a way that could discredit Together or bring it into disrepute.

Resignation

Members may give notice of their resignation from Together at any time by written notice with reason for leaving. Resignation is effective as of the date that Together receives this written notice.

Exclusion

Members can have their relationship with Together terminated for the following reasons:

Non-payment of membership fee:

Organisations receive an invoice for the annual membership fee after being approved by the board and thereafter in February each year.

- 1. For any organisation which has not paid the membership fee or had communication with Together to give a reason five months after first invoiced and which has received at least one reminder.
- 2. If no communication or payment is made a further email is sent with a 30-day deadline for response, stating that membership will be terminated unless payment is received.
- 3. The membership benefits are suspended and the organisation is removed from mailing lists.
- 4. The organisation will be presented as withdrawn at the following board meeting.

Organisations can re-join as members as soon as the membership fee is paid.

Bringing Together into disrepute, lack of commitment to Together's mission, vision, values and/or acting incompatibly with the UNCRC:

1. If a member's behaviour or position is, or has the potential to be, detrimental to the interests or reputation of Together, this can be raised by Trustees at a board meeting. If a member has a concern about another member, they should raise this with the director of Together via the <u>complaints procedure</u>.

Members can be excluded for acting incompatibly with Together's mission, vision, values, anti-racism work, the responsibilities of being a member and the principles enshrined in the UNCRC.

- 2. Exclusion of members may be put forward by the Board of Trustees, after they have heard the defence of the party concerned and if two thirds of Trustees present agree.
- 3. If exclusion is recommended by the board, the member is informed and receives a written notice explaining the reason for exclusion. All membership benefits and rights will be suspended.
- 4. Within two weeks of expulsion, the member is able to appeal that decision. If the Together Director receives any such notice of appeal within that period (time being of the essence), the Trustees shall convene an Extraordinary General Meeting (EGM) for a date no later than two months after the date of expulsion, and the organisation or individual concerned shall be entitled to make representations to the members at that EGM. Together may, at any such EGM, resolve by ordinary resolution that the organisation or individual concerned should be re-admitted to membership or become a supporter.

To re-join as a member, the organisation must be able to demonstrate how they have taken steps to align with Together's values, mission and vision. Re-admission remains at the discretion of the board.



Together's jargon and acronym buster!



At Together we often inadvertently find ourselves using technical language and acronyms. In an effort to make our work, and the language of children's rights in general, more accessible to members, we list below some of our most frequently used terms:

Children's Scheme: Scottish Government's plan for implementation of the UNCRC Bill. It sets out how they will comply with children's rights and report on progress annually.

CEDAW: The Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW) is an international treaty which defines what constitutes discrimination against women and sets up an agenda for national action to end such discrimination.

CRIA: A child rights impact assessment (CRIA) is a tool to assess how a proposed law, policy or budgetary allocation will impact the realisation of children's rights. Scottish Government has a similar version of this called Child Rights and Wellbeing Impact Assessments (CRWIA).

Human Rights Bill: A new Human Rights Bill will incorporate four United Nations Human Rights treaties into Scots Law. The new Bill will be introduced in this parliamentary session.

ICCPR: The International Covenant on Civil and Political Rights (ICCPR) is an international human rights treaty which enshrines civil and political rights, including rights to: life; privacy; freedom of thought, conscience and religion; freedom from torture.

ICERD: The International Convention on the Elimination of All Forms of Racial Discrimination (ICERD) is an international treaty which defines racial discrimination and sets out measures to eliminate it.

ICESCR: The International Covenant on Economic, Social and Cultural Rights (ICESCR) is an international human rights treaty which covers economic, social and cultural rights, including rights to: education; fair and just conditions of work; an adequate standard of living.

ISG: Together's Implementation Strategy Group (ISG) – a Subgroup of member organisations. The ISG is a forum through which Together members can work to support and scrutinise the implementation of the United Nations Convention on the Rights of the Child (UNCRC). Read more on p13.

LOIPR: Together's <u>List of Issues Prior to Reporting (LOIPR) report</u> collates the experiences and expertise of Together's members about key children's rights issues in Scotland as part of the UNCRC monitoring process.

SHRC: The Scottish Human Rights Commission (SHRC) is an independent public body with a general duty to promote awareness, understanding and respect for all human rights.

SOCRR: Every year, Together publishes the State of Children's Rights Report (SOCRR) which aims to monitor implementation of the United Nations Convention on the Rights of the Child (UNCRC) in Scotland.

SIB: The Strategic Implementation Board (SIB) is a Scottish Government group of government, private and NGO stakeholders (including Together) that provides strategic oversight of UNCRC implementation in Scotland.

The UN Committee on the Rights of the Child: The Committee on the Rights of the Child, is the body of experts that monitors implementation of the Convention on the Rights of the Child by its State parties.

UNCRC: The UN Convention on the Rights of the Child (UNCRC). See p17.

UNCRPD: The UN Convention on the Rights of Persons with Disabilities (UNCRPD) is an international human rights treaty of the United Nations intended to protect the rights and dignity of persons with disabilities.

UPR: The Universal Periodic Review (UPR) is a process which involves a review of the human rights records of all UN Member States.
